NASA Open House Today

Balloons, traffic, cotton candy and plenty of alcoholic and non-alcoholic beverages. Most of the southeast corner of Houston is having a big time today at the Ballunar Festival. while a *few* of us are in the office slaving away (the few, the proud, the morons – no, wait, that's Marines, isn't it?). NASA is having an open house, today, too.

Aircraft Intercomparison

The intercomparison effort concluded at least in part successfully. Unfortunately, as I understand it, the G-1 had some battery problems and had to break off about half-way (5minutes into the second leg) through the intercomparison flight. Michael Trainer suggested that he hoped the amount of time they did have would be sufficient - ah, confidence.

Fortunately, given the truncated intercomparison, the remainder of the TexAQS Houston airforce made the best of their remaining flight time by taking a long, hard look at the high ozone conditions in the boundary layer over downtown and the western part of the ship channel. All of the aircraft encountered ozone levels in excess of 200 ppbv and these high levels were mirrored at the surface stations.

Weekend Weather Forecast

John Nielsen-Gammon provided the weather forecast today but Fred Fehsenfeld provided the entertainment when he asked John to "read the meteorological tea leaves" several days ahead. John indicated that he was having orange juice today, not tea, and that he'd have to read the "pulp," to which Fred replied, "oh, that would be pulp fiction then." Fred, we must admit, has wonderful timing.

Just as predicted yesterday, today's weather is just the ticket for interesting secondary pollution production and accumulation. A high pressure system over Louisiana continues to produce favorable pollution conditions for today, tomorrow and Monday.

Macroscale circulation aloft continues light and from the southeast. These light upper level winds allow the formation of a surface level land breeze - off the land and towards the Bay and Gulf - at night and enhance the formation of the bay breeze - off the Gulf/Galveston Bay to the land at midday.

This morning, Debby was just a shell of her former self, a tropical wave bringing squally thunderstorms and heavy rains to Cuba. Models, which to date have not performed well with Debby, show the wave continuing to move west and emerging over the open Gulf in a day or two. If enough remains, the system could possibly regenerate then, perhaps, threaten the Yucatan and the western Gulf.

Electra N308D

Yesterday, after the intercomparison, the Electra conducted a bay breeze/urban area characterization flight from the Gulf through the north side of Houston.

Today the Electra is having a hard down day.

Tomorrow the Electra will conduct a midday sea breeze/urban characterization flight from the Gulf and following a standard ladder or stack pattern across the Houston metro area.

G-1 N701BN

The G-1 left the intercomparison party early yesterday but, fortunately for us all, the indicated problems have been resolved.

The G-1 is conducting two 2.5 hour flights today - one at 9:30 AM and the other at 2:00 PM.

The G-1 plans a hard down day tomorrow.

Today and tomorrow the DC-3 will conduct midday urban/sea breeze characterization flights. Mostly clear conditions are forecast.


Twin Otter N153BU

Yesterday, after the intercomparison flight, the Twin Otter conducted a urban area characterization flight back

forth and across the high ozone/precursor rich I-10 corridor Houston. Maximum ozone levels of than 200 ppbv more were encountered. Before returning to Ellington the Twin Otter also flew the a refinery plume and measured over 60 ppbv of SO₂.

Two land breeze/sea breeze characterization flights are planned for today. The early flight left Ellington at 7:15 AM with a later flight planned for 12:00 noon.

Tomorrow, the Twin Otter will conduct two (9:30 AM & 12:30 PM) transition model validation flights consisting of multiple legs and spirals over Galveston Bay, La Porte, and Ellington.



Interesting Conundrum

According to the EPA AIRNOW website, the Figure depicts the maximum 1-hour ozone concentration for the Houston area yesterday. It is interesting to note that the "official" hourly ozone data provided to EPA "missed" the maximum running hourly ozone concentrations encountered by the Houston surface sites. According to the "preliminary" official data yesterday did not show an exceedence of the 1-hour ozone standard.

TNRCC's Dan White says he's not surprised at the incongruities and that the "peaky" nature of ozone production in Houston often leads to such apparent differences.

NASA Road One East to 146 South, go over the Kemah Bridge at turn left at first light, go to 4-way stop, turn left and follow the signs.

The Aquarium - on the Kemah Boardwalk is one of the most beautiful and interesting theme restaurants that I have been to in a long time. The entrance to the restaurant is adorned with a three-story high aquarium, that runs up the revolving stairs. Inside they have a number of tanks, the largest - a 50,000 gallon tank - houses a variety of incredibly beautiful fish, a couple of rays and several sharks. They also have several side tanks with exotic fish from Japan and Hawaii among other places. Be sure to mention that this is your first visit to your host, so you can benefit from the "full treatment."

As visually stimulating as the setting is, the food matched it in every way and was absolutely incredible. I had the daily house special. The meal consisted of stuffed blackened redfish topped with shrimp and crawfish in a creamy white wine sauce served with squash, carrots, boc-choy and Spanish rice. It was all EXCELLENT.

The Kemah Boardwalk also offers several boat rides and has a large number of theme restaurants and bars. All in all I would rate Aquarium as an astounding four stars. It is a MUST EAT establishment for special occasions!!

Note: It is a little heavy on the wallet, but it is well worth the money so you won't mind.
